B. *Precaution Education*

Preventive education work should focus on the daily inspection and it can effectively improve the efficiency of the safety work, such as to prevent the occurrence of fire in the campus, to prevent the destruction of criminal elements and to thwart the hostile forces inside and

outside the territory. Such education is mainly in order to safeguard the national security and stability of the school's public security, which ensure the safety of the whole school teachers and students from the foundation. What's more is to carry out fire safety education using a variety of typical fire accidents and the actual situation of the school so as to reduce the damage caused by the accident.

C. Management Education

Only good management work can ensure the smooth operation of various tasks. In order to reduce the safety accidents in colleges and universities, it is necessary to strengthen the safety management education for the administrative staff in colleges and universities. This work should be carried out in many aspects. First of all, the administrative staff should respond to the national security policy, organize the whole school teachers and students to study the rules related to safety education management constituted by the Provincial and Municipal People's Congress and interiorize the idea of safety management education. Secondly, the administrative staff should implement the safety management education to specific individuals, so as to promote the smooth progress of the safety management work. Finally, they should establish a sound security management system. A work with system will be more clear, and it can maintain the campus security in colleges and universities through strengthening the safety management education.

D. Rectification Education

Rectification education is to rectify the security incidents that have occurred. In the work of rectification education, we need to formulate a complete work plan to rectify the school's unsafe factors step by step so as to ensure and improve the elimination rate of unsafe factors.

E. Safety Function Education

Safety function education is the most important part of the security management education in colleges and universities. The security departments should do their own work and make full use of the safety function education. The security departments in colleges and universities should plan the contents of daily safety management, use a variety of ways to achieve the goal of safety function education, and give counsel to school's safety.

F. Safety Protection Education

The object of safety protection education is all the teachers and students in colleges and universities. It should be composed of individual and collective parts, and the first is the safety protection education of individuals. In the event of danger, the teachers and students should ensure good self protection and fully exert their abilities of self protection during the safety protection. They can only contribute their own strength to the safety of the school if they protect themselves well, and thus the school's security has been guaranteed through the strength of solidarity.

II. PROBLEMS EXISTED IN THE CURRENT SECURITY EDUCATION IN COLLEGES AND UNIVERSITIES

A. 2.1 Teachers in Charge of Safety Education do not Pay Attention to Work

Because of the indifference of leadership towards the safety education, the teachers responsible for the safety education are skeptical to the work and do not pay enough attention. B. 2.2 Supervision in Colleges and Universities is not enough

There is no corresponding safety education management department in college and university is the important reason for the incomplete implementation of safety education work. Therefore, the supervision of the internal security education in college and university is not enough and lack of certain deterrent force. Moreover, the education department has not applied a certain pressure to colleges and universities, so there is nobody to supervise if the college students' safety education classes have been taught or not. The safety education classes offered by the school are very few, and there is no stipulation about teaching mode and necessary safety contents. In this case, lack of supervision for a long time, the security education in colleges and universities has been neglected.

C. Class Hours of Safety Education Cannot Be Guaranteed

In the daily education in colleges and universities, the school mainly opens up the professional courses and attaches great importance to them, and therefore its curriculum arrangement almost occupied all the courses of students. Many teachers believe that safety class is a waste of time for students, and there is no need for a long time to explain. Coupled with many school arrangements for the professional class, class hours of safety education cannot be guaranteed. Because there is not enough class schedule, so the effect of safety education in colleges and universities is poor, resulting in that its development is comparatively slow and even become a mere formality

III. SCIENTIFIC CONNOTATION OF SAFETY EDUCATION

A. *Safety Education Is an Important Part of University Management*

With the development of the times, safety education has become an important part of modern university education, which is of great significance to the development of security in colleges and universities. The rapid development of society has a higher demand for talent, which requires the development of education in colleges and universities to get rid of the traditional exam-oriented education and to cultivate comprehensive talents for the community. Carrying out safety education can let students understand the situation of social security in a timely manner and is conducive to enhance the safety awareness of teachers and students, so that they understand the responding security measures. By mobilizing all the teachers and students to maintain the stability of the school is advantageous to prevent the society from the intelligent crime and the security crime, and is conducive to strengthen the security of society as well as colleges and universities.

C. *To Carry Out Safety Education Is the Need for the Security Status of Colleges and Universities*

Due to the university students having not entered the society, their thoughts are comparatively simple and lack of precaution awareness, which gives criminals an opportunity. For example, some criminals haunt in the campus frequently and sneak into dormitories to steal when students are in class or going out; some criminals say they are business people and cheat students out of money through the transaction; the most serious is some lawless elements often rob students' money and endanger their personal safety. And then it will promote the implementation of the safety education and to provide effective conditions for the safety management of colleges and universities.

C. *To Enhance the Safety Responsibility Consciousness of College Students*

It is all related to teachers and students' weak safety responsibility consciousness that the safety accidents occurred frequently, the safety management is difficult and the effect of management is not significant. Because the students spend the most of time on study, they contact with books more and all they learned are theory; they rarely go to the community to practice and will not often go out of the world, so the social experience of college students is generally insufficient. Safety

education in colleges and universities should continuously improve students' sense of safety responsibility, and establish their concept of safety responsibility. Specific methods are as follows, the safety education management personnel can develop their security responsibilities and enhance students' safety awareness by carrying out lectures, conducting safety education propaganda irregularly or posting slogans related to security education in the campus, which is not only beneficial to the healthy development of students, but also can cooperate with the smooth conduction of school safety management work smoothly and promote the further development of colleges and universities.

V. CONCLUSION

Safety education plays an important role in the safety management of colleges and universities. Colleges and universities should constantly carry out reforms in safety education, further study the theory of safety education, and pay attention to combining safety theory with safety practice to ensure safety education be truly implemented and to enhance the efficiency of safety management in Colleges and Universities.
